Core Curriculum Requirements, Electives, and College Requirements

(In general, 200-level courses can be taken first year or later, and 300-level can be taken second year or later. As courses may not be offered every year, 400-level courses should be taken third year if offered.)

- A minimum cumulative GPA of 2.750 for all designated licensure courses (see Educator Preparation Handbook for more information)
- Earn a minimum cumulative GPA of 2.500
- · Receive a passing score on the Communication and Literacy Skills Test (reading and writing) of the Massachusetts Test for Education Licensure (MTEL)
- Receive passing scores on the appropriate MTEL Subject Tests
- Earn minimum grades specified for designated course (see the Educator Preparation Handbook)
